

The Health, Medicine, and Society Major

The HMS major is a 32-credit Bachelor of Arts program. To complete the major, students take breadth core courses, courses in a depth concentration, and additional electives as follows.

Foundational Core Courses (12 credits)

Students choose one course from each of the three core categories.

Depth Concentration (12 credits)

Students choose one of the following concentrations.

Health Humanities	or	Social Science Approaches to Health
Students choosing a <i>Health Humanities</i> concentration take 12 credits of HMS courses that have a Humanities (HU) designation. Possible courses that fit this concentration are found in departments such as English, Religion Studies, Philosophy, and History.		Students choosing a <i>Social Science</i> concentration take 12 credits of HMS courses that have a Social Science (SS) designation. Possible courses that fit this concentration are found in departments such as Psychology, Sociology/Anthropology, Journalism, and Economics.

Additional HMS Coursework (8 credits)

Students take 4 credits of HMS coursework that has an attribution (HU, SS, or NS) that does not match their concentration. For example, a student doing the *Health Humanities* concentration must take 4 HMS credits that have either a SS or a NS (Natural Science) designation.

Students take 4 more credits of HMS coursework in any designation.

Additional Requirements for Completing the HMS Major

- The HMS major requires students to declare a second major outside of HMS. The second major can be from any department or program at Lehigh.
- No more than 2 courses in the Depth Concentration and Additional HMS Coursework can be cross-listed with the home department/program of a student's second major.
- At least 3 courses in the Depth Concentration and Additional HMS Coursework must be taken at the 300-level.
- There is no sequencing in the HMS major, meaning students can take the needed coursework in any order.

The Health, Medicine, and Society Minor

The HMS minor is a 16-credit minor program. To complete the minor, students take 1 core course, and 12 credits of additional HMS coursework as follows.

Core Course (4 credits) <i>Choose one course from the following list.</i>
